The Government of the Republic of Namibia has received financing from the African Development Bank hereinafter called the Bank toward the cost of the Namibia Agriculture Mechanization and Seed Improvement Project (NAMSIP), and intends to apply part of the proceeds toward payments under the contracts for **Supply, Delivery and Installation of Shade Nets and Water Tanks for Karas and Omaheke Regions** in two (02) lots as follows:
 - (a) Lot 1: 2 No. Shade Nets and 2 No. Water Tanks for Karas Region
 - (b) Lot 2: 2 No. Shade Nets and 2 No. Water Tanks for Omaheke Region

For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

2. The Ministry of Agriculture, Fisheries, Water and Land Reform (MAFWLR) now invites sealed Bids from eligible Bidders for the **Supply, Delivery and Installation of**

Shade Nets and Water Tanks for Karas and Omaheke Regions in Namibia. The Delivery Period is 3 months, and no margin of preference is applicable.

3. Bidding will be conducted through the Open Competitive Bidding (National), (OCBN) method as specified in the Bank's [Procurement Framework](#) dated 2015 and is open to all eligible bidders as defined in the Procurement Framework.
